- The contractor or facility owner is to notify inspector listed on the report 48 hours prior to performing **underground** cleanouts.
- To ensure proper disposal, contractors may be required to provide dump tickets showing dump site, date, amount dumped and contractor to jpslater@howardcountymd.gov, or 9801 Broken Land Parkway, Columbia, MD 21046.
- A contractor that performs repair or maintenance on an **underground** stormwater facility must also have the training and credentials required under applicable state and federal law, including an Oil Operations Permit from the Maryland Department of the Environment and a Confined Space Certification from the federal Occupational Safety and Health Administration (OSHA).
