<u>Termination of Credit</u>. The tax credit created by this section shall terminate and the Public Safety Officer will not be eligible if any of the following occur:

The Public Safety Officer is no longer employed full time by the Public Safety Agency, or no longer eligible under subsection (d) for volunteer firefighters or emergency medical technicians and:

If the Public Safety Officer was separated from employment "for cause" as set forth in section 1.115 of this Code, the former Public Safety Officer shall be liable for:

All of the property taxes that the officer would have been liable for in the taxable year of the separation of employment, as if the tax credit had not been granted under this section;

I hereby certify that I have read County Code § 20.129F and that I am eligible for the tax credit for the residential property described above. I understand that this is a tax credit that can be received against the County property tax. The tax credit may be granted in an amount up to \$2,500, but not to exceed the amount of county tax due on the property.

I own the property to which the credit will be applied; it is used as my principal residence; and I will occupy the property for more than 6 months of a 12-month period.
