Technology Fee

In order to defray the cost of replacing the Environmental Health data management processing system for the Health Department, a technology surcharge is established and will be collected on all uncapped established fees. The amount of the technology surcharge is 10% of the approved fee rounded to the nearest dollar. The listed fees reflect the "10% surcharge".
