The African American Community Roundtable held a Parent Forum at Celebration Church to inform parents re. the Parent Concern process for Howard County. The next Roundtable Forum will host a Fall Education Forum on 9/28 at 7 p.m. at Howard High School. Frank/Rev. Turner will let Commissioners know about upcoming forums.
- *Law Enforcement* – *Opel & Tim* – Tim will offer his services to the HCPD re. Sensitivity Training as it relates to the LGBTQA community. The training should last approximately 90 minutes. Tim will confirm with Dr. Sands re. dates. Dr. Sands met and had discussions with the Police Chief, Lieutenant, Deputy Chief, and Major regarding concerns, training, etc. with the Police Academy as well as with veteran officers.
- *HRC Awards Program* – *Ivette and Bianca* – Two nominations have been received. Stephanie will re-circulate the nominations to everyone. Nominations will be discussed at the October meeting. The updated nomination forms are on the county's website under the Office of Human Rights tab.
- *Human Trafficking Task Force* – *Dr. Sands* – Members of the Anti-Human Trafficking Commission met on Sept. 2nd. Members from Safe House, Hope House, and other agency representatives came to join the meeting and offer more information. There are funds being set aside for victims. OHR is partnering with several other counties, as well as the state to combat this heinous situation. 32 representatives from various agencies attended this meeting.

- *Aging & Disability Matters* – *Bianca* – Stephanie circulated information re. 50 Plus Expo being held on 10/16.
