Regular attendance during your term of Teen Court is mandatory. Excused absences may be granted by the Teen Court Coordinator; however, missing more than one session will result in the forfeiture of your accrued Student Service Learning hours.

Applications must be submitted by December 14, 2018 to kturner@howardcountymd.gov. Please ensure your email address and phone number are clearly printed on the application. The number of applicants accepted per school may be limited to ensure a fair and impartial jury.

Accepted applicants will be notified via email prior to December 28, 2018. Adding my email address to your contacts may prevent email(s) from going to your spam folder. If we are unable to contact you by email, you may miss your opportunity to participate in this Teen Court session.

HOWARD COUNTY TEEN COURT DRESS CODE AND CONDUCT, BEHAVIOR

These rules and guidelines apply to respondents as well as all volunteer participants in the courtroom. It is important to remember that you are participating in a court of law and that your manner of dress and your conduct must display the proper respect for the court.

DRESS CODE – Strictly Enforced! Please adhere to avoid being sent home.

They cannot be worn when you are on the witness stand.</p>	<ul style="list-style-type: none"> • Jeans of any kind! NO EXCEPTIONS! • T-shirts! • Hats! • Shorts or cut-offs! • Pool type flip-flop shoes! • TANK TOPS/SPAGHETTI STRAP shirts or other sleeveless spandex shirts! • Bare midriffs – shirt and pants/skirts must meet! • Spandex leggings unless worn with skirt of proper length!

No text-messaging at any time! Cell phones will be taken. • Do homework or other work in the courtroom or jury deliberation room! • Carry on private conversations in the courtroom or deliberation room! • Display anger or lose your temper! • Bring food or drinks to court! • Chew gum in court!
