ARTICLES OF INCORPORATION

FIRST: I, Stephen F. White, whose post office address is Suite 300, 20 S. Charles Street, Baltimore, Maryland 21201, being at least eighteen (18) years of age, hereby form a corporation under and by virtue of the General Laws of the State of Maryland.

SECOND: The name of the corporation (which is hereafter called the "Corporation") is Cleannet U.S.A., Inc.

THIRD: The Corporation shall be a close corporation as authorized by Title 4, of the Corporations and Associations Article of the Annotated Code of Maryland, as amended.

FOURTH: The purposes for which the Corporation is formed are:

(1) To engage in building maintenance and janitorial services, including, but not limited to, dusting, sweeping, waxing, buffing, sanitizing, window cleaning, etc.; and to engage in such other activities as are incidental to or connected with the operation of such business.

(2) To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes, the attainment of any of the objects, or the exercise of any of the powers herein set forth, either alone or in conjunction with other corporations, firms, or individuals, and either as principals or agents, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the above-mentioned objects, purposes, or powers; and

(3) To do anything permitted by Section 2-103 of the Corporations and Associations Article of the Annotated Code of Maryland, as amended from time to time.



FIFTH: The post office address of the principal office of the Corporation in this State is Suite 300, 20 S. Charles Street, Baltimore, Maryland 21201. The name and post office of the Resident Agent of the Corporation in this State are Stephen F. White, Suite 300, 20 S. Charles Street, Baltimore, Maryland 21201. Said Resident Agent is an individual actually residing in this State.

SIXTH: The total number of shares of capital stock which the Corporation has authority to issue is Five Thousand (5,000) shares of common stock, without par value.

SEVENTH: The Corporation elects to have no Board of Directors. Until the election to have no Board of Directors becomes effective, there shall be one (1) director, whose name is Faramarz Mark Salek.
