ARTICLES OF INCORPORATION
OF
J&M TRUCKING, INC.
(A Close Corporation)

THIS IS TO CERTIFY:

FIRST: That I, FRANCISCO A. CASTRO, whose post office address is 2507 Woodberry Street, Hyattsville, Maryland 20782, being of full legal age, does under and by virtue of the General Laws of the State of Maryland authorizing the formation of corporations hereby sets forth his intention to form a close corporation.

SECOND: The name of the corporation is:

J&M TRUCKING, INC.



THIRD: The Corporation shall be a close corporation as authorized by Title 4 of the Corporations and Associations Article of the Annotated Code of Maryland, as amended.

FOURTH: The purposes for which the Corporation is formed and the business or objects to be carried on and promoted by it are as follows:

- a. To act as a general contractor and subcontractor for the hauling and trucking services and the doing of any and all other business and contracting incidental thereto, or connected therewith, and the doing and performing of any and all acts and things necessary, proper or convenient for or incidental for the furtherance of the carrying out of the powers or purposes herein mentioned.
- b. To engage in the business of snow removal, salt spraying, and towing.
- c. To engage in the business of trash removal.
- d. To enter in the business of moving, removing, transporting, loading and unloading any and all kinds of soil, or any product of construction, excavation, dismantling, demolition or related work of any kind, germane to construction, repairing, remodeling, excavation or demolition on public or private work.
- e. To improve and operate, to sell, convey, assign, mortgage, or lease any real estate and any personal property.
- f. To borrow money and issue evidences of indebtedness in furtherance of any or all of the objects or its business and to secure the same by mortgage, deed of trust, pledge, or other lien.

g. To enter into, perform and carry out contracts of any kind necessary to, or in connection with, or incidental to the accomplishment of any one or more of the purposes of the corporation.

h. To carry out all or any part of the forgoing objects as principal, factor, agent, contractor, or otherwise, either alone, or through or in conjunction with any person, firm, association, or corporation, and in carrying on its business for the purpose of attaining or furthering any of its objects and purposes, to make and perform any contracts and to do any act and things, and to execute any powers suitable, convenient, or proper for the accomplishment of any of the objects and purposes therein enumerated or incidental to the powers herein specified, or which at any time may appear conducive to or expedient for the accomplishment of any of such objects and purposes.

i. To carry out all or any part of the aforesaid objects and purposes, and to conduct its business in all or any of its branches in all or any states, territories, districts and possessions of the United States of America and in foreign countries, and to maintain offices and agencies in any or all states, territories, districts and possessions of the United States of America and in foreign countries.

j. To exercise and enjoy all the powers, rights and privileges granted to or conferred upon corporations of a similar character by the General Laws of the State of Maryland now or hereafter in force, and the enumeration of the foregoing powers shall not be deemed to exclude any powers, rights, or privileges so granted and conferred.

FIFTH: The post office address of the principal office of the Corporation in Maryland is 2507 Woodberry Street, Hyattsville, Maryland 20782. The name and the post office address of the resident agent of the Corporation in Maryland is Francisco A. Castro, 2507 Woodberry Street, Hyattsville, Maryland 20782.

SIXTH: The aggregate and total number of shares of stock of all classes that the corporation has authority to issue is five thousand (5,000). All of the shares are common stock at no par value.

SEVENTH: The Corporation elects to have no Board of Directors. Until the election to have no Board of Directors becomes effective, there shall be one (1) Director whose name is Francisco A. Castro.

EIGHTH: The duration of the Corporation shall be perpetual.
