II. New Business

A. Electric Scooter Sharing Program Discussion

Sharon Maneki, Director of Legislation and Advocacy, NFB-MD

Chris Eatough, Howard County Office of Transportation

- Electric Scooter Sharing Program - Bill CB3-2020- tabled by county council – Next vote due legislative session Monday 3/1/20.

Concerns

- Scooters are dock- less. Operators are permitted to ride scooters on the sidewalk.
- Scooter Operators may be careless about blocking entrances/bus stops, curb cuts.
- Scooters are quiet therefore a person may be unable to tell if one is approaching from behind.
- Concerns over mishandling of scooters – Scooter company has a 3-hour span to properly take care of any mishandling of scooters – after the 3-hour span and nothing is done, the County will handle the issue.

Suggestions/Recommendations:

- Commission needs to collaborate with County to think of what can be done to make scooters accessible and ensure that accessibility for pedestrians is not hampered.
- County needs to make sure Scooter companies educate riders.
- Scooter company will provide some designated parking areas as well as some docking stations.
- Scooter company is 100% reliable for all riders.
- The County, along with Columbia Association to partner in educating Scooter operators.
- Designated zones for Scooter riders – Oakland Mills/Gateway/Downtown Columbia.
- All riders are responsible for the handling of scooters and must sign a waiver.
- Hours of operation for scooters: From midnight to 5:00 a.m. there will be no scooter activity.
- Suggestion made for Access Committee to review permit and if possible, hold emergency commission meeting to discuss.
- Motion: Special Meetings: Access Committee to work with community partners impacted as well as members of commission to identify concerns. Commission wants to be involved and have impact on decision making. Motion passed unanimously.
- It was decided by the CoD that a special meeting will be held on March 16 to consider the recommendations of the Access Committee with respect to whether to support the concerns raised in the National Federation of the Blind – Maryland Chapter's (NFB-MD) letter, Support for CB3-2020 with Amendments, undated, as submitted by Sharon Maneki, Director of Legislation and Advocacy, NFB-MD (Letter was previously submitted to the Commission and reviewed at the 2/24/20 Commission meeting); (2)The Draft Terms and Conditions for the Permit to Operate a Publicly Accessible Electronic Scooter Sharing Program on Public Right-of-Way in Howard County;

B Approval of Minutes for December 9, 2019 meeting

- Cindy made motion to approve December minutes as written – Dr. Jones seconded the motion – passed unanimously.

C. 2020 Awards Program

- This year marks 30th Anniversary of the ADA.
- Discussion to have art contest this year with the artwork to be displayed in the lobby of George Howard Building.
- Reviewed proposed art contest official rules & procedures with suggested themes for 2020.
- Motion made for theme for Awards 2020 Program: Disability. Equity. Inclusion. One County. Accessible to All. Passed unanimously.
- Contest will be open to all Howard County residents.
- Commission will need to reach out to community to those who would be interested to serve as a judge.
- Motion to display/judge artwork. Passed unanimously.

D. Licensure of Sign Language Interpreters

Commission members expressed concern that some sign language interpreters in Maryland lack competency. There is an interest in statewide licensure/certification for sign language interpreters. On March 16 there will be a one-hour special CoD meeting to discuss recommendations regarding mandatory sign language interpreter licensure/certification in Maryland. The recommendations, if any, will be drafted in a letter and submitted to the County Executive.
